In our Institute, we are always trying to maintain the highest quality in all activities as per the need of all the stakeholders and mapping with our vision and mission as follows:

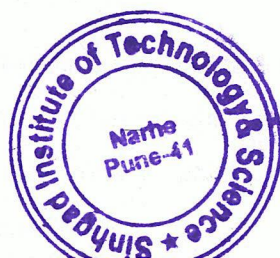
- To plan and supervise various activities to maintain the quality.
