Feedback on Syllabus from Stakeholders

MCA is a professional course, related to software development and other technical and managerial aspects of software industry. SPPU strives to keep the MCA syllabus up-to-date so that the students should not face difficulties when they enter the software industry. They should be well trained to be easily accommodated by the software industry. SPPU revises the syllabus usually after every three years, or as and when required considering the current trends of software industry.

The expert faculty members working with SPPU in various affiliated colleges contribute to keep the syllabus updated as per the market requirements. BoS i.e. Board of Studies approves and finalises the recommendations of these expert faculties to form the revised syllabus.

MCA course has four stakeholders viz. students, teachers, alumni and employers. While designing the syllabus, inputs from these stakeholders are taken into consideration as they recommend the contemporary needs of software industry.

Students and teachers involved in the teaching-learning process are on the campus. Alumni work in various companies and employers always look forward to employ MCA students well-versed in recent technologies. Hence, it is need of the hour to consider the inputs from all these stakeholders during syllabus revision. The institute also takes feedback from these stakeholders and tries to improvise based on the inputs or suggestions provided. A printed syllabus feedback form is used to collect the feedback from the students and teachers. The feedback from the alumni and employers is collected through Google form.

Till 2019 MCA programme was of three years duration, and since 2020 it is of two years duration. By the time students start with their third semester, they are well versed with it. Hence, the feedback is collected from them in third semester.

Feedback from the teachers is collected usually after a year of introduction of the revised syllabus. By this time they are also familiar with the new pattern, and have the idea that to what extent it will be beneficial to the students for being employable.

The alumni feedback is usually collected on the current syllabus, after six months of their placement through Google form. During this period they understand how they are to what extent they can implement the knowledge acquired during their MCA programme.
