7. Complete specification required for patenting, etc.

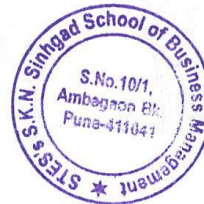
The lecture was full of knowledge as most of students were unaware of this procedure of filling patents.

The explanations given by madam were highly appreciable.

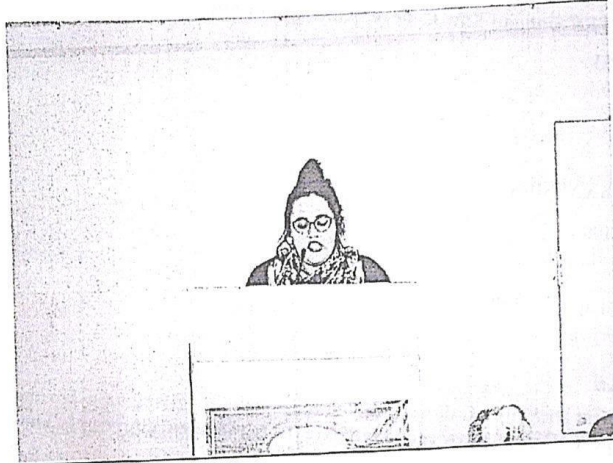

Summary of the Session



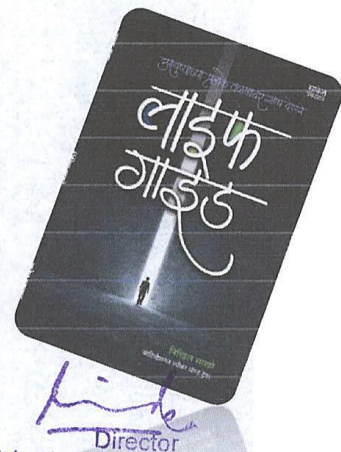

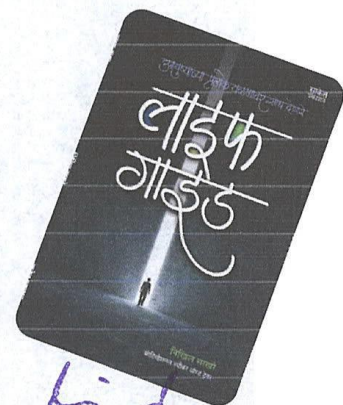

Summary of the session

The life transforming seminar held in our college by motivational speaker Mr. Nikhil Sakhre. Our guest is a motivational speaker. He is also a writer, Author, Corporate Trainer, Consultant. He conducted 700+ seminars successfully. According to him, 1.5 lakh personalities have changed by this session. He is the youngest writer in the history of SAKAL newspaper. His book "LIFEGUIDE" is remarked by Achyut Godbole and Yamaji Mankar.

The session started with the statement "Nothing is Impossible." It's only our belief in something which either makes it possible or impossible.

For example, According to all known laws of aviation, there is no way that a bee should be able to fly. Its wings are too small to get its fat little body off the ground. The bee, of course, flies anyway. Because bees don't care for what humans think, is impossible.

The Universal Laws of Success

There are seven universal laws of success and they are as follows:

1. Law of Unity:

Even though we are all experiencing our own Illusion of Reality, we all are One. We are the same creature. We all are in Unity with the Omnipotent One. When we Love others, we Love ourselves. When we wish others harm, we wish harm to ourselves. As we judge others, we judge ourselves. As we do unto others, we do unto ourselves. The more completely we Love ourselves, the more completely we Love everyone else, too. We all are One.

2. Law of Thinking:

You're probably wondering how there could even be a law of thought, but while it may not be a written and scientifically verifiable physical law, such as the law of gravity for example, it is very real nonetheless. So what kind of law would govern thought and how can it be used to any advantage?

The short answer is that the way in which thought is actively used can affect the way in which the body reacts to it and that can directly or indirectly affect a person's health in the physical sense while it can also affect a person's emotional state. In a more ethereal sense, thoughts can also influence the way in which a person lives his/her life, so in that sense, it can dictate to a greater or lesser extent whether the person lives happily, abundantly and fully or they live miserably, in poverty and in a limited and restricted way.

3. Law of Attraction:

It is the ability to attract into our lives whatever we are focusing on. It is believed that regardless of age, nationality or religious belief, we are all susceptible to the laws which govern the Universe, including the Law of Attraction. It is the Law of Attraction which uses the power of the mind to translate whatever is in our thoughts and materialize them into reality. In basic terms, all thoughts turn into things eventually. If you focus on negative doom and gloom you will remain under that cloud. If you focus on positive thoughts and have goals that you aim to achieve, you will find a way to achieve them with massive action.

4. Law of Supply:

“Grab the opportunity,” How many times have we heard that, right? But what does it really mean? Life is the greatest opportunity we've been given. That's step one. Step two is all of the enormous opportunities to grow that God has bestowed upon us. But it's our responsibility to recognize them, grab them, and then act on them sensibly. Most people either aren't paying attention or they don't realize the importance of opportunities. They respond to opportunity in a lethargic manner over a prolonged time. To put it simply, “if we grab the right opportunity at the right time, we will achieve great success in our life.”

5. Law of Non-Resistance:

It states that when we resist a condition, person, or thing that we don't like or want, we are adding power to it. This is usually opposite of what we think our resistance is doing. We think by resisting something that it will go away or leave us alone. Resistance keeps us stuck. Non-resistance allows us to go free.

6. Law of Receiving:

If you are not receiving the good you want in life, ask yourself, “What can I give, to make way to receive my good?” Then freely and quickly give it! There are those pious souls who will say, “Oh, but when I give, I am not supposed to expect to receive.” And so, of course, they do not receive. Their very attitude blocks their good. Quite the opposite is true: When you give you can and should expect to receive. It is the law of the universe.

7. Law of Success:

It states that there is no failure, only the degree of success varies. For example, if an adult and a year old are made to run for a distance, the adult will do it quickly, however the one year old will take some time to do it. He will walk two to three steps, he will fall, again he will get up, walk a few more steps, again he will fall and in the end he will cover the distance.

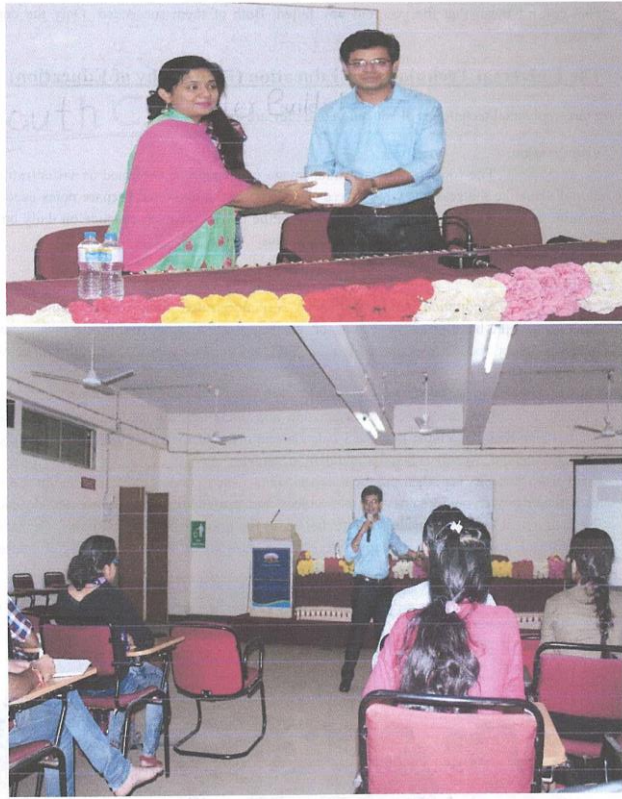

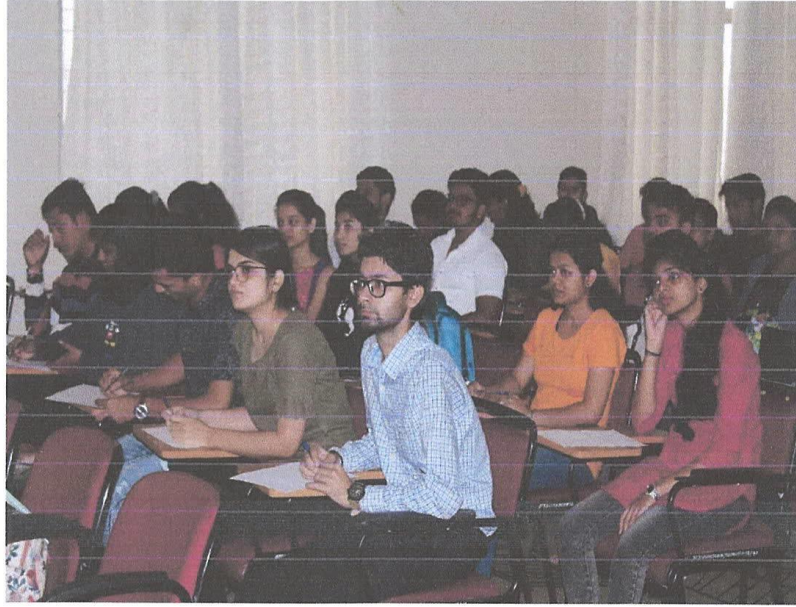
